A CT Road Master Program *ELECTIVE Workshop*

In this workshop, participants will learn proper flagging techniques and the responsibilities of a flagger in a work zone. This course satisfies the ATSSA Flagger Certification curriculum. Satisfactory completion of this course certifies participants for four (4) years and places them on ATSSA's national registry. A certification card will be mailed to you upon your successful completion of this course.
